

# Livin' It Up Quiz Feature Twitter Competition Rules

## Prize

3 x monthly R2 000 cash prizes (that will only be deposited into a Capitec account held by each lucky draw winner).

## How to enter

1. Download the Capitec Livin' It Up mobile game from your app store (existing players to update to the latest version of the game)
2. Play Livin' It Up to help any character reach their dream and complete the quiz that pops up during their work journey
3. Use the camera to take a screenshot of the boost you achieved on the **boost earned** or **job done** screen
4. Share the screenshot on Twitter with the official hashtag **#BoostYourDream** and tag **@CapitecBankSA** to enter (one post will count as a valid entry)
